AGREEMENT FOR PAYMENT OF GOODS AND COLLECTION

For and in consideration of the sale of goods and services and the extension of credit to applicant by Louisiana Seafood Exchange, Inc. the undersigned Corporation, Partnership, Proprietorship, or natural person(s) hereby agree to the following terms and conditions upon acceptance of this application by Louisiana Seafood Exchange, Inc.

1. Prompt payment shall be made to Louisiana Seafood Exchange, Inc. of all sums due and owing upon demand. All balances are net according to invoice terms unless payment is required sooner by Louisiana Seafood Exchange, Inc.
2. Upon default in payment of obligations due and owing to Louisiana Seafood Exchange, Inc., and in the event collection proceedings, including legal actions, are instituted by Louisiana Seafood Exchange, Inc. for collection, the undersigned hereby agrees to pay all costs, expenses and attorney's fees (25%) incurred by Louisiana Seafood Exchange, Inc. pursuant to the collection or attempt to collect said amount.
3. If applicant is a Corporation, the officer signing on behalf of the Corporation must also sign below as an individual, hereby agreeing to guarantee the payment when due of all charges for goods sold by Louisiana Seafood Exchange, Inc. to applicant, together with attorney's fees (25%) and costs and disbursements incurred by Louisiana Seafood Exchange, Inc. in the collection of said amount.
4. Finance/service charge on past due and unpaid balances shall accrue at the rate of 1½% per month, and the undersigned agrees to pay all finance/service charges on past due accounts.
5. The terms of this agreement are contractual and not merely recitals, and are intended to bind the heirs, executors, administrators, successors, and assigns of the applicant.
6. In the event that legal proceedings are instituted by Louisiana Seafood Exchange, Inc. pursuant to the collection of the said debt owed, the undersigned agrees and stipulates to the venue of the said proceedings to be Jefferson Parish, State of Louisiana.

The undersigned has read all of the provisions of the above credit application and payment agreement, understands the terms and conditions herein, and hereby consents to the same. If signed by a representative of a Corporation, the undersigned hereby verifies that he has the actual and requisite authority to bind the Corporation to this document and execute this agreement on behalf of the Corporation.
